Discussion	<p>Cllr Norton has resigned from the Speedwatch Group due to work and personal commitments. Cllr Tee thanked him for his service. Parishioner Kevin Scrase has taken over the running of the group and would make up a rota for more structured approach. He needed more volunteers however. The Group have completed 4 observations so far and had sent the data to the police. They in turn send cautionary letters to drivers caught speeding. Cllr Tee said that any data gathered should also include types of vehicles and asked if the Traffic Group could have a copy of what is sent to the police.</p> <p>The Highways Improvement Plan proforma has been received. It looks very complicated and also requires information on sources of funding. Parishioner Pauline Catterall mentioned several sources of grants. She would also contact St Margarets village to find out what progress they have made with a similar problem of speeding.</p>

PUBLIC INPUT AND OTHER BUSINESS		
Discussion	<p>The trees bordering St Mary's Close and Hillcroft, Vicarage Lane were still getting overgrown.</p> <p>UK Power Networks had recently cleared some branches in Vicarage Lane and had left them there.</p> <p>There was a discussion regarding the recent spate of burglaries, vandalism at the church and a break in at the Royal Oak. The speeding motorcycles were also an issue. Cllr Clayton said that any issues at all should be reported to the police on the 101 telephone number. He said that the police wouldn't always respond but made up a log of the calls and would be useful historical data.</p> <p>The field opposite Prima had been used for access to steal from sheds etc. and the farmer had now put a padlock on the gate on the footpath while waiting for a Kissing Gate to be installed. This was proving inconvenient for walkers and Cllr Tee said he would contact the landowner to try to speed things up.</p> <p>Any problems e.g. drains, flytipping etc. can be reported on the following KCC website.</p>
